President's Message

Computer Club and Friends:

You may be wondering why there was a sudden flurry of updated privacy policies showing up in your inbox this past month. It seems like every website I ever visited was sending me an email informing me of an update to their privacy policy. Did I read them all? No! The gist appears to be a rush to incorporate the provisions of the **General Data Protection Regulation** (GDPR), which went into effect on May 25, 2018. The GDPR is a regulation in the European Union governing the gathering of personal data of individuals within the European Union. It also addresses the export of personal data outside the EU. Websites are required to let you know what may happen to any personal information you provide. Data collection permission will require a clear affirmative action by the user such as checking an unchecked box which indicates consent or typing "Yes, I agree".

In addition to the notifications of data collection and the legal ramifications for misuse of the collected data, there is also a requirement to obtain explicit consent, notify users in cases of a hack or breach, and appoint a dedicated data protection officer(s) and have a recovery plan as well as much more. Since the advertising business today is largely driven by people's personal information, this is a big issue. Already complaints about Google and Facebook are being investigated.

The fines for misuse of your personal data can be staggering; I've read 4% of Global Revenue! So, sites that conduct business in the European Union are scrambling to comply; thus we see the flurry of updated privacy policies.

While there is little the average consumer can do other than choose to agree or disagree to a website's privacy policy, it helps to be aware of just what data is collected and how it may be used to market to you!

Here in the United States, Verizon Communications, AT&T Inc., and Sprint Corporation have recently pledged to stop selling location information to middlemen accused of mishandling that data. Didn't realize your location information was being collected and used? Location data is available through a data-sharing agreement with companies who then allow businesses to tap into the data for information to use in their marketing efforts. Wonder why you get an ad for something on sale when you are in the store that is having that sale!? Use of this data ranges from truck rental services using data to better assist customers on the road and banks who use the data to determine the user's proximity to their home as part of fraud prevention. Customers agree to share location data with services such as Uber, Lyft and Google maps, for instance, and many wireless carriers sell anonymized location data to marketers. Some of this location data was provided to law enforcement by a prison phone service provider and allowed access to any cell phone user's location. This data found its way onto a website that let corrections officers find any cellphone user's location without a court order.

As we begin to understand the extent to which user data is used and how it is monetized, it may pay to read some of the privacy new policies. However, the answer choice remains either Yes, to use the service, or No and don't use the service.; there's no other choice.

In China the government is now using camera's embedded in the sunglasses of police officers for surveillance and to identify suspects. They also have cameras in college classes monitoring the students' response to a lecture and can advise an instructor in real time when he or she is losing the class's interest, or when the students do not understand the material.

Tom's Tech-Notes

Customizing Your Android Home Screen

Overview



I was recently working on the handouts for my "Android for Beginners" seminar and making quite a few screen shots on my Android Phone. As I got to the material about Display Settings, I got to thinking about what options were available to customize my Home Screen.

I had been using the LG default home screen background, which was a busy set of gray and black triangles, reminiscent of a backgammon board pattern. I went looking for a setting that would let me just have a plain color as my background. There was no such option on my LG Phoenix 3 with Android 7 (Nougat). What to do?

There WAS an option to use a picture/image of my choosing. So, I said to myself "Self? Can you make an image of a plain background color, or even better, a gradient that fades subtly from light to dark?" A milli-second or two later, I had determined exactly how to proceed.

I'll detail those steps for you in the following, along with a few other Home Screen settings that you might want to try. The screen shot at left shows the final results.

Disclaimer: The screen shots and steps given here are for a LG Phoenix 3 running Android 7 (Nougat) with AT&T as my carrier. Your own Android phone may be slightly to wildly different.

Making the Background Image

My favorite Windows tool for creating and editing images is the free **Paint.Net**. Among its palette of tools is a gradient tool that lets you create a canvas that lets you create a smooth fade from one color to another. I started Paint.net with a new, empty canvas. I set the canvas size to 480 wide by 792 tall, which is the size in pixels of my 5-inch LG Phoenix 3 phone's screen. Your phone's screen metrics may be different.

Next, I went to the Paint.Net color mixer and selected, for my primary color, a medium copper. I then selected, for my secondary color, a dark copper. You can select any two colors, but the more different they are, the more banded your gradient will look.

Next, I selected the gradient tool and, on the toolbar, chose "linear". I positioned my cursor at the top of the canvas in the exact center and then dragged down to the bottom of the canvas. The canvas filled with the medium copper to dark copper gradient. I then saved the canvas (image) as TomWallPaperCopper.jpg.


Moving the Image to the Android Cell Phone

I used a USB cable to connect my cell phone to my Windows PC. The phone has to be powered on and you will likely have to use the swipe down settings menu to change the USB connection from charging to MTP (data) mode. On your Windows PC, the phone will appear in "This PC" as a new attached device. You can then use Windows file management functions to copy files to / from your Android device. I copied my new gradient image (TomWallPaperCopper.jpg) to the DCIM\Camera folder on my LG smart phone. This folder is part of the Android Gallery.

Setting the new image as the Wallpaper for the Home Screen

I returned to the smart phone and selected **Settings>Display>Home screen>Wallpaper**.


I then tapped Gallery as my source. Within the Gallery, I navigated to and tapped the image of the copper gradient.



I then tapped OK and finally, on the confirm prompt, tapped Set. I did *not* check the checkbox to use the same image as my lock screen background. This made my copper gradient image the background for the home screen. Note in the screen shot above that I had also made a medium blue to black gradient. I used that image as the background for my phone's lock screen.

You can create any number of similar background images or use favorite pictures (properly cropped and sized) as backgrounds. Let your imagination go wild.

Choosing Your Home Screen Style



Select **Settings>Display>Home screen>Select Home** and you will have a choice of three basic Home Screen styles. The default is Home.

If you don't like endless swiping to find App icons, you may want to try EasyHome or Home & app drawer as alternatives.


The App Drawer is an icon that, when tapped, shows all the App icons on a separate screen.

Summary

Your Android Home Screen, much like your Windows Desktop, is a place you spend a lot of time on when using your smart phone. It's worth taking a little time to get it set up in a way that makes it easy and comfortable for you to use.

There are many other settings you may choose to tweak. If, in the course of experimenting, you get off into the weeds, you can always go back and revert to the original factory defaults.

Don't Buy Identity Theft Insurance

Updated from David's original June, 2017 article

Equifax

It was almost a year ago when Equifax announced that a data breach exposed the sensitive personal information of 143 million Americans. As a part of its mitigation, Equifax offered consumers a year of free credit monitoring. This offer ended in January 2018, but not to worry, for just \$12.95 a month you can pay Equifax to monitor your credit reports.

This is a breathtaking bit of corporate chutzpah; first Equifax fails to secure many millions of individual's data files (including probably yours) and now that they have proven to be untrustworthy they want to charge a monthly fee to assure you your data has not been compromised. I would just say NO!

LifeLock

LifeLock is the most heavily advertised consumer data protection service that is offered by Symantec, a cyber security company that also provides the Norton Security Suite.



LifeLock premiered in 2005; you might remember the commercials at that time featuring LifeLock CEO Todd Davis revealing his Social Security number to the public. LifeLock failed to disclose that Davis' identity was stolen at least 13 times during the advertising campaign. LifeLock brushed off critics, claiming that LifeLock prevented Davis' identification from being stolen many other times, thereby proving the value of LifeLock.

LifeLock attempts to frighten consumers by saying:

"Considering everything you do online, data breaches and companies that sell your information, it's easier than ever for criminals to steal your identity. They can open accounts, buy properties, and even file tax returns in your name. There's a new victim every two seconds, so don't wait to get protection!"

But, of course, LifeLock has the answer:



Note that LifeLock does not offer a family plan; LifeLock coverage for a married couple is well over \$50 a month. LifeLock does offer a 11% discount when a couple enrolls.

So, What Do You Get for Your Money?

Sadly, very little, except for a false sense of security. If you are the victim of identity theft, most institutions will absorb the cost and charge you nothing. The few consumers who do suffer monetary damages rarely lose more than \$200.

Go to LifeLock's website and you will notice that "Not all transactions at all accounts monitored" is written everywhere - on the website, as the signature to their emails, at the bottom of their site next to any disclaimer asterisk - basically giving them an out in case anything actually ever happens to one of your accounts.

A close reading of all of LifeLock's service and reimbursement "guarantees" discloses so many exceptions and conditions that they are essentially worthless.

LifeLock's Legal Woes

The Federal Trade Commission in 2015 asserted that LifeLock violated a 2010 settlement by continuing to make deceptive claims about its identity theft protection services, and by failing to take steps required to protect its users' data. In late 2016 LifeLock paid consumer damages of over \$100,000.000.00.

In documents filed with the U.S. District Court for the District of Arizona, the FTC charged that LifeLock failed to live up to its obligations under the 2010 settlement, and asked the court to impose an order requiring LifeLock to provide full redress to all consumers affected by the company's order violations.

The 2010 settlement stemmed from previous FTC allegations that LifeLock used false claims to promote its identity theft protection services. The settlement barred the company and its principals from making any further deceptive claims. It required LifeLock effectively safeguard personal data it collected from customers, and required LifeLock to pay \$12 million in consumer refunds.

How Can I Protect Myself?

The Equifax and LifeLock primary service is nothing you can't do much better yourself. If you think someone has stolen your identity, you can contact each of the four major credit bureaus, TransUnion, Experian, Equifax, and the newer Innovis, and place an electronic security freeze on your credit. The freeze is good until you lift it, and should prevent any new accounts from being opened. A security freeze prohibits, with certain specific exceptions, the consumer reporting agency from releasing the consumer's credit report or any information from it without the express authorization of the consumer. You can temporally lift the freeze if you want to open new accounts.



There is no charge for a security freeze if you are a victim of identity theft. To get a free security freeze you should first file a police report or (much more easily) create an Identity Theft Report at:

www.identitytheft.gov/Assistant#w hat-to-do-right-away

This FTC site is easy to navigate and has some good information on what to do after an identity theft.

Conclusions and Recommendations

Don't buy identity theft insurance from Equifax, LifeLock, or any of the other outfits selling this "protection".

The best way to protect yourself against loss is to keep an eye on your own bank, credit card and brokerage accounts and statements. Download your annual free credit reports yourself, safeguard your passwords, and skip the fees.
